| do. ... | 30 | Footpath ... | — | From the Parish boundary at Great Work Mine to Godolphin Hall (amended route in O.S. 402 and 866). |
| do. ... | 48 | Footpath ... | — | Amended route: from Path 2 to Tranno and Tregew. |
| do. ... | 50 | Footpath and road used as public path. | Footpath ... | From the Porthleven Cliff road to the coastal path at Tremearne Cliff. |
| do. ... | 56 | Bridleway and footpath. | Footpath ... | Amended route: from Bridge Hill at Godolphin Lower Downs to Godolphin Cross, running south-west at Maiden Stamps. |
| do. ... | 74 | Footpath ... | — | Amended route: from Path 46 at Keneggy Sand along the coastline of the Parish to Helston, running nearer the coast at Rinsey Head and avoiding dangerous sections at Trewavas Head and Tremearne. (Western section deleted.) |
| do. ... | 77 | Footpath ... | — | From Rinsey to Path 74 at Trewavas Cliff: addition of two spurs to Path 74 at Rinsey Cliff and Trewavas Cliff. |
| do. ... | 2 | Footpath and road used as public path. | Footpath ... | Amended route: from Breage village to the C.C. road at Tregew. |
| Gunwalloe ... | 3 | Footpath ... | — | Amended route: from Path 4 at the quarry south of Chyvarloe along the coast to Church Cove. |
| do. ... | 4 | Footpath and bridleway. | Footpath ... | Amended route: from the Helston boundary at Loe Bar parallel with the coast to the road fork near Berepper. |
| Cury ... | 11 | Footpath ... | — | Amended route: from Parish boundary and Path 10 in Gunwalloe to Parish boundary and Path 7 in Gunwalloe (western section to Polgreen deleted). |
| Grade-Ruan ... | 8 | Footpath ... | — | Amended route: from Poltesco (Caerlean Cove) to Cadgwith village along the "Man o' War path" (extension from the Cadgwith Hotel). |
| Landewednack | 10 | Footpath ... | — | Amended route: from Tretheras Manor to Landewednack Church. (Spur to the Balk deleted.) |
| do. ... | 12 | Footpath and road used as public path. | Footpath ... | From Cross Common via Tretheras to the Parish boundary near Gwavas. |
| do. ... | 14 | Road used as public path. | Footpath ... | Amended route: from the Lizard-Helston road to the junction with Paths 30 and 31 midway between the western boundary of O.S. 174 and the north-eastern boundary of O.S. 312 (Carnagoon). The western section from Carnagoon to the car park is deleted. |
| do. ... | 16 | Footpath and road used as public path. | Footpath ... | Amended route: from Tregaminion Farm via Penolver Cottage to Path 2 north of Bass Point House. |
| Mullion ... | 1 | Footpath and road used as public path. | Footpath ... | From Kynance Cove via Kynance Farm to Predannack Wollas (loop east of Lower Predannack Cliff is deleted). |
| do. ... | 2 | Footpath and road used as public path. | Footpath ... | From Predannack Wartha to the C.C. road north of Predannack Wollas (northern and southern sections being C.C. roads). |
| do. ... | 4 | Road used as public path. | — | Amended route: from Parc Venton via Garah to the Parish boundary near the main Helston-Lizard road. The words "Private Road" deleted from the statement. |
| do. ... | 10 | Footpath ... | Road used as public path. | From Trevithoe via Meaver-Crease to the Mullion road at Meaver (amended route). |
| do. ... | 11 | Footpath ... | — | Amendment: right of way on western side of O.S. 395 and not on eastern side of O.S. 456. |
| do. ... | 24 | Footpath ... | — | Amended route: from Path 25 to the old quarry at Meaver and along the southern edge of the quarry to join the Mullion road. |
| do. ... | 25 | Road used as public path. | Footpath ... | From Trudnoe to the road at Meaver. |
| do. ... | 39 | Road used as public path. | Footpath ... | From Predannack Wartha to Path 61 at Mullion Cliff. |
| do. ... | 44 | Bridleway ... | Footpath ... | From Kynance Farm to Soap Rock. |
| do. ... | 50 | Road used as public path. | — | Amended route: from the Mullion road east of Isle of Wight to Path 4. |
| do. ... | 51 | Road used as public path. | — | Amended route: from the Mullion-Predannack road 200 yards north-east of Teneriffe to Path 4. |
| do. ... | 58 | Footpath and road used as public path. | Footpath ... | From Polurrian Cove to Carrag-luz. |
| St. Keverne ... | 24 | Footpath ... | — | Amended route: from Penare to Porthallow Cove, extension of path across beach to join Path 19. |
| do. ... | 43 | Footpath ... | — | Extension around Dolor Point past the Paris Hotel to the end of the road above Coverack Harbour. |
| do. ... | 52 | Road used as public path. | Footpath ... | Amended route: from the road opposite lodge at Quillets via the kissing gate south of Lanarth House to the main road west of Lanarth. |
