

NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT, 1949.

COUNTY OF CORNWALL.

Survey of Public Rights of Way.

NOTICE is hereby given that the Cornwall County Council, in exercise of the powers conferred upon them by Sub-section (3) of Section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Map and Statements prepared under Section 27 of the above-mentioned Act in relation to the Rights of Way within the area of the Rural District of West Penwith in the County of Cornwall by:—

- (1) the deletion of the paths indicated in the First Schedule hereto;
- (2) the inclusion of the paths indicated in the Second Schedule hereto;
- (3) the amendment of the paths indicated in the Third Schedule hereto;
- (4) the amendment of the Statement as indicated in the Fourth Schedule hereto.

Maps and Statements showing these modifications have been deposited at the offices of the Clerk to the Council, West Penwith R.D.C. Council Offices, 38, Chapel Street, Penzance and at the office of the County Planning Officer, County Hall, Truro, where they may be inspected free of charge during normal office hours.

Copies of the Maps and Statements relating to each of the Parishes in the Rural District are available for inspection by arrangement with the Parish Clerks concerned.

Any objection or representation in respect of these determinations should be made in writing and addressed to the Clerk of the County Council at the County Hall, Truro, before the 9th day of March, 1957.

Ludgvan	A	Footpath ...	From the Rosevidney-Truthwall Road along Parish boundary to Path 58 in St. Hilary Parish.
ditto	B	Footpath ...	From road near Lower Tremenheere, to road near Tregassack.

ditto	C	Bridleway ...	From road between Lower Ninnes and Higher Gear to New Mill.
ditto	D	Footpath ...	Spur from Path 32 running south-west to Penzance M.B. boundary at Hea Moor.
ditto	E	Footpath ...	From road near Lower Tremenheere to the Tolver Road.
Marazion	A	Footpath ...	Extension of Beacon Lane, with Malthouse Lane.
Paul	A	Footpath ...	Along the coast from Path 5 to Lamorna Cove via Penzer Point and Carn-du.
Perranuthnoe	A	Footpath ...	From Trevean Lane to Trevean Cove.
St. Buryan	A	Footpath ...	From the main Penzance-Land's End Road (opposite Path 20 in Sancreed) to Boscawen Noon.
ditto	B	Footpath ...	Along the coast from Boscawen Point to Lamorna Cove.
St. Hilary	A	Footpath ...	From Path 3 at Wrass Head, round the coast to Path B above Piskies Cove, with spur to Piskies Cove.
ditto	B	Footpath ...	From Path 3 across the promontory to Piskies Cove, and along the coast and round Cudden Point to Path 6 above Arch Zawn.
ditto	C	Footpath ...	From Path 56 north-east to main road opposite Chynoweth.
