

SECOND SCHEDULE.

Rights of Way Added.

Sevenoaks Urban District.

F.P. In Knole Park from No. 45 crossing Nos. 43 and 32 and the carriage drive and joining No. 37.

F.P. In Knole Park from No. 37 to No. 43 near King John's Oak.

*Sevenoaks Rural District.**Chevening Parish.*

F.P. From N.W. corner of Dutchmore Wood following Parish boundary on Chevening side of boundary hedge and connecting with road from Knockholt Village to Star Hill Road.

Chiddingstone Parish.

F.P. Short length running W. from road angle S. of Mountjoy connecting with No. 22.

F.P. Continuation of No. 40 N. to Hill Hoath Corner.

F.P. From White Post N. along Parish boundary to Stonewall Park Lodge.

F.P. Connecting Nos. 69 and 70 near Parish boundary south of Prinkham.

F.P. From opposite Methodist Church at The Hoath S.W. to the county road near The Forest.

Cowden Parish.

B.R. From county road W. of Scarlets S.E. to County boundary.

Kemsing Parish.

F.P. Connecting Nos. 13 and 24 near Rising Sun.

B.R. Brushwood Cottage, Pilgrims Way, S. to Heverham Road.

Penshurst Parish.

F.P. From junction of Nos. 60, 62, 63 and 65 near Spring Hill N.W. across Walter's Green Road to Coldharbour Road at Coldharbour.

Riverhead Parish.

F.P. Connecting Chevening No. 40 N.W. of Whitley Mill with Mill Bank.

Seal Parish.

F.P. Fawke House N.E. to No. 35 near Lower Fawke Farm.

B.R. Rooks Hill from White Cottage S. to junction with No. 43 E. of Cawings.

Sevenoaks Weald Parish.

F.P. From White House Road S.W. of White House S. and W. to Wickhurst Road N. of Wickhurst Manor.

Shoreham Parish.

Road used as public path (C.R.F.). From London Road between Fox's Garage and Badger's Cafe, E. across Orpington By-pass along Badgers Road to Shacklands Road.

Sundridge Parish.

F.P. From Church E. to No. 5.

B.R. From Dryhill S. to Chevening No. 16.

B.R. From No. 6 E. of Sundridge Place E. and N.E. to Dryhill Lane.

THIRD SCHEDULE.

Variation of Routes.

*Sevenoaks Rural District.**Chiddingstone Parish.*

No. 45. F.P. From E. boundary of O.S. 981 to proceed N. to No. 39 instead of proceeding N.E. to join No. 39.

Cowden Parish.

No. 27. F.P. From the bridge in Birchcote Shaw the route to proceed in northerly direction to Parish boundary instead of proceeding first E. then N.W.

Kemsing Parish.

No. 13. F.P. To proceed along S. and W. boundaries of O.S. Nos. 209 and 206 instead of crossing those fields.

Penshurst and Chiddingstone Parishes.

No. 11 (Penshurst). F.P. Instead of crossing O.S. 40A, to proceed (partly in Penshurst and partly in Chiddingstone) along N.E. boundary and part of N.W. boundary of such field and then E. to road N. of Somerden Green.

Penshurst Parish.

No. 12. F.P. From junction with No. 11, to proceed towards Chested along the S. and E. boundaries of O.S. 52 and the S. and E. boundaries of O.S. 62 and not across such fields.

No. 32. F.P. To proceed along the N. boundary of O.S. 475 and along N.W. and N.E. boundaries of O.S. 299 instead of crossing those fields.

Sundridge Parish.

No. 32 (part). F.P. To proceed along the S. boundary of O.S. 665 instead of N. boundaries of O.S. Nos. 715, 716 and 717.

Westerham Parish.

No. 21. F.P. To be shown as leaving road at French Street immediately S. of Holly Tree Cottage and as proceeding S.E. and then along farm road between O.S. Nos. 33 and 33b.

FOURTH SCHEDULE.

Change of Designation.

*Malling Rural District.**Wrotham Parish.*

No. 45. Road used as public path (C.R.F.) to F.P. West Yaldham W. to Parish boundary N.E. of Lower St. Clere.

*Sevenoaks Rural District.**Brasted Parish.*

No. 36 (part). Road used as public path (C.R.B.) to B.R. From No. 40 S. of Henden Manor Farm W. and N. to S.E. corner of O.S. 453.

No. 40 (part). Road used as public path (C.R.F.) to B.R. From Sundridge No. 29 at Henden Manor Farm S. to Brasted No. 36.

Chevening Parish.

No. 18. Road used as public path (C.R.F.) to B.R. From Back Lane S. through Green Lane Farm to road B 2042 N. of Whitley Farm House.

No. 20 (part). Road used as public path (C.R.F.) to F.P. From road B 2042 at Whitley Farm House S.E. to Whitley Mill.

No. 28 (part). Road used as public path (C.R.F.) to F.P. From county road at S.E. corner of Sheephill Wood E. to S.W. corner of Keating Wood.

No. 42. B.R. to F.P. Joining Nos. 20 and 27 at Apps Bottom.

Chiddingstone Parish.

No. 38 (part). B.R. to F.P. From Hill Hoath S.E. to county road at S.E. corner of The Slips.

Cowden Parish.

No. 23A. Road used as public path (C.R.B.) to B.R. From county road at The Moat S. to County boundary.

Edenbridge Parish.

No. 40. Road used as public path (C.R.B.) to F.P. From Four Elms Road (B 2027) E. of Little Broxham S. to No. 53 at Lockhurst.

Kemsing Parish.

No. 10. Road used as public path (C.R.F.) to F.P. From county road N.E. of Heverham E. to Parish boundary N. of Lower St. Clere.

Leigh Parish.

No. 32 (part). Road used as public path (C.R.F.) to F.P. From Penshurst Road near Cinder Hill S.E. to Park Farm.

Otford Parish.

No. 4 (part). Road used as public path (C.R.F.) to F.P. Section crossing the railway near Newall.

Sevenoaks Weald Parish.

No. 12. F.P. to road used as public path (C.R.F.). Mount Pleasant Road S.W. to Hale Oak Road.

Sundridge Parish.

No. 14. B.R. to F.P. Manor Farm S.E. and S. through Hawks Wood to Parish boundary N. of Mackerels Plain.

No. 27. Road used as public path (C.R.F.) to F.P. From county road opposite Old Forge Cottages N. to Boarhill.

No. 28. Road used as public path (C.R.F.) to F.P. Boarhill S.W. past Chain Farm to road B 2042 N. of Oakwood Lodge.

No. 29. Road used as public path (C.R.B.) to B.R. Road B 2042 opposite Oakwood Lodge S.E. to Parish boundary at Henden Manor Farm.

Westerham Parish.

No. 55 (part). Road used as public path (C.R.F.) to F.P. From county road S.W. of Chartwell in an easterly direction along N.E. and E. boundaries of Buddle's Wood.
