Survey of Rights of Way

Notice is hereby given that the County Council of the West Riding of Yorkshire in exercise of the powers conferred on them by sub-section (3) of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the draft rights of way map and statements prepared under section 27 of the National Parks and Access to the Countryside Act, 1949, in relation to the rights of way within the areas of the Boroughs of Goole and Pontefract, the Urban Districts of Adwick le Street, Bentley with Arksey, Conisbrough, Dearne, Knottingley, Maltby, Mexborough, Rawmarsh, Selby, Swinton and Wath upon Dearne, and the Rural Districts of Doncaster, Goole, Hemsworth (in relation only to the Parishes of Kirk Smeaton and Little Smeaton), Kiveton Park, Osgoldcross, Rotherham, Selby and Thorne by the deletion and addition of the public paths indicated in the Schedule hereto and shown on a map which has been deposited at the office of the County Engineer and Surveyor at 93 Northgate, Wakefield, and which may be seen there until the 2nd day of January 1961, free of charge, between the hours of 8.45 a.m. and 5.20 p.m. on each week-day (other than Saturday).

During the same period copies of the map so far as the same relate to each of the County Districts affected will be on deposit and may be inspected free of charge during normal office hours at the respective Council Offices except in the Urban District of Adwick le Street where a copy of the map will be on deposit at the Town Hall, Adwick le Street.

Copies of the map so far as the same relate to the Rural Districts of Doncaster, Goole, Osgoldcross, Rotherham and Selby will also be on deposit during the same period at the following places:

Doncaster Rural District—The Memorial Hall, McConnell Crescent, Rossington.

Goole Rural District—The offices of the Rawcliffe Internal Drainage Board, 154 High Street, Rawcliffe.

Osgoldcross Rural District—The offices of Poskitt (Beal) Ltd., Low Road, Beal.

Rotherham Rural District—The West Riding County Council Highway Depot, Northfield Lane, Wickersley.

Selby Rural District—The offices of William Webster and Son (Timbers) Ltd., Timber Merchants, Burn.

Any representation or objection with respect to these determinations shall be made in writing addressed to the Clerk of the County Council, County Hall, Wakefield, before the 3rd day of January 1961, and shall state the grounds on which it is made.

Additions—Footpaths, from Doncaster—Rotherham Road near Lime Grove to the boundary with Conisbrough Parks Parish. Bridleway, Castle Inn via Windgate Cottage to the boundary with Conisbrough Parks Parish.

DEARNE URBAN DISTRICT.

Deletions—Footpaths, Chapel Lane; Green Lane to West Moor Lane.

Additions—Footpath, near Merrill Road.

KNOTTINGLEY URBAN DISTRICT.

Deletions—Footpaths, Broomhill Grove to Broomhill Crescent; Along northern bank of Canal from Junction House to near Stubbs Bridge with branch to the School. Bridleway, from the Vicarage towards Spawne Bone Lane.

Additions—Footpaths, Womersley Road to Broomhill Crescent; Cattelaith Lane. Bridleway, Doveroyd House to Cattelaith.

MALTBY URBAN DISTRICT.

Deletions—Footpaths, Along Grange Riding, Tickhill Riding and Upper New Riding; Sandbeck Lane to the Blythe Road at Stone Grange.

MEXBOROUGH URBAN DISTRICT.

Deletions—Footpaths, near the Railway Station; Swinton Road towards the Railway Station.

Additions—Footpath, Ferryboat Lane to the River Don.

RAWMARSH URBAN DISTRICT.

Deletions—Footpaths, Aldwarke Road towards Rotherham Road.

Additions—Footpath, Kilnhurst Road towards Russell Road.

SELBY URBAN DISTRICT.

Additions—Footpath, Massey Street to Brook Street.

SWINTON URBAN DISTRICT.

Deletions—Footpaths, near Terrace Inn; near Swinton Road Railway Bridge.

Additions—Footpaths, Broomhill Street via Kilnhurst Steel Works to Wharf Road; Highborne Road to Steel Works; near Carlisle Street; North of Springfield Road.

WATH UPON DEARNE URBAN DISTRICT.

Deletions—Footpaths, Church Street to Cemetery Road; Adby Road along Roman Rig Dyke into Wath Wood; Newhill Road to Brook Dyke; Fitzwilliam Street to Sandy Gate. Bridleway, Low Common Lane.

Additions—Footpath, near Wath Wood.

ADWICK UPON DEARNE PARISH

Deletions—Footpaths, near Manor Farm; Lousy Busk Lane; Hoy Lane

ARMTHORPE PARISH.

Deletions—Footpath, in Long Plantation.

Additions—Footpaths, in the vicinity of Lime Tree Avenue, Chestnut Avenue, and Almond Avenue; at Mere Lane.

ASKEARN PARISH.

Deletions—Footpath, near Askern Brick and Tile Works.

BARNBURGH PARISH.

Deletions—Footpath, Mill Lane.

BARNBY DUN WITH KIRK SANDALL PARISH.

Deletions—Footpath, Marsh Lane to Canal.

BAWTRY PARISH.

Deletions—Bridleways, A.1. to Spring Gardens Lane; alongside Railway off Bridge Lane; Wharfe Street to River Idle. Footpaths, along bank of River Idle; Church Street to Wharfe Street.

Deletions—Bridleway, Head Lane.

Deletions—Footpaths, Grange Lane to A.1.

Deletions—Footpath, Constitution Hill to Steely Iron Works.
