Survey of Rights of Way

Notice is hereby given that the County Council of the West Riding of Yorkshire in exercise of the powers conferred upon them by subsection (3) of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the draft rights of way map and statements prepared under section 27 of the above-mentioned Act in relation to the rights of way within the areas of the Boroughs of Castleford and Harrogate, the Urban District of Garforth and the Rural Districts of Nidderdale, Ripon and Pateley Bridge, Tadcaster and Wetherby by the deletion and addition of the paths indicated in the Schedule hereto and shown on a map which has been deposited at the office of the County Engineer and Surveyor at 93 Northgate, Wakefield, and which may be seen there until the 15th day of April 1963, free of charge, between the hours of 8.45 a.m. and 5.20 p.m. on each weekday (other than Saturday).

During the same period copies of the map so far as the same relate to each of the County Districts affected will be on deposit and may be inspected, free of charge, during normal office hours at the respective Council Offices.

A copy of the map so far as the same relates to the Rural District of Nidderdale will also be on deposit during the same period at No. 13 Church Lane, Boroughbridge, and may be inspected, free of charge, between the hours of 9 a.m. and 5 p.m. on each weekday (other than Saturday).

Any representation or objection with respect to these determinations shall be made in writing addressed to the Clerk of the County Council, County Hall, Wakefield, before the 16th day of April 1963, and shall state the grounds on which it is made.
